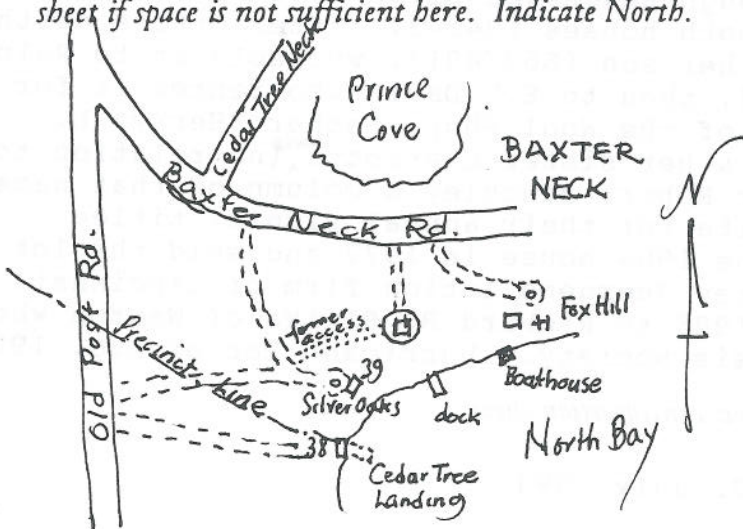

BUILDING FORM

ARCHITECTURAL DESCRIPTION *see continuation sheet*

Describe architectural features. Evaluate the characteristics of this building in terms of other buildings within the community.

Ranch style house of two stories, entered from north on top level, into living room with glass on two sides facing south to use solar heat from the waterside. The floor plan is an ell, with master bedroom with picture windows on the water, east, and kitchen, utility room & garage in wing to north. On the lower level are 3 bedrooms, 2 baths & rec room. The interior has redwood trim and Welsh brick floor. Exterior is shingle with white trim. Open deck on water side.

Until 1977 access was on road across the Halenbecks' and Ammens onto Old Post Rd.

HISTORICAL NARRATIVE *see continuation sheet*

Discuss the history of the building. Explain its associations with local (or state) history. Include uses of the building, and the role(s) the owners/occupants played within the community. Earlier owners included Nymphas & Charles Marston, Rev. Phineas Fish and Prof. James Metivier (see OP 39 cont). On a one acre lot bought from Metivier in 1904 Mary Isabel (Hanson) Waterhouse widow of Francis A. Waterhouse Jr. headmaster of Boston English Highschool, and herself a teacher & head of Newton Teacher School 1872-4, built a shingle sty summer house (deed 268/415). Her son Francis A. III sold it in 1939^(339/241, 334/312) thru Hel McLellan's associate Sally Sawyer to Otto L. Halenbeck (1869-1944), retired transport head of Socony to protect the house of his son Arthur to the south (OP 39), and for a guest house. Although beach was paved by Camp Candoit in World War II, Halenbecks summered in both houses 1942-3. After Otto's death his widow Clara L. (Miller) gave it to her son (663/491), who sold it to Ralph David Hinckley of Osterville (708/424), then to E.K. Davis who rented it for a decade to "the Wooly Girls", founders of the Wool Shop: Esther "Herky" L. Herschenroeder, Janice Upham (d.1988) & her sister Charlotte^{Davis} (no relation to them). They called it "Wits End" c.1950 after Robert Benchley's column of that name. Ralph Cahoon made a painting of the site for their annual picnic, titled "Woolshop Outing". Davis tore down the 1904 house in 1977 and sold the lot to William T. Moeller, retired VP of Andrew Juergens lotion firm of Cincinnati, who built this house. He sold it in 1988 to Richard B. Slifka of Weston who on board of national multiple sclerosis society. Hurricane Bob of Aug. 1991 did much damage to dock and to deck.
