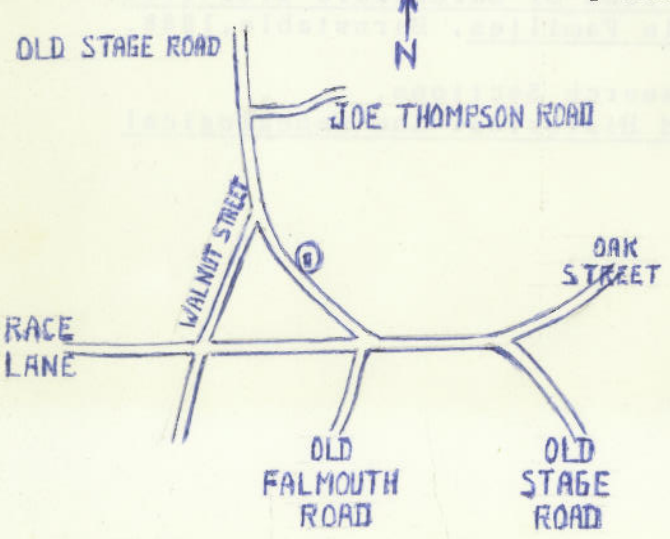

GIVE A BRIEF DESCRIPTION OF SUBJECT MATTER AND/OR DESIGN OF MONUMENT

The monument was initiated and financed by Douglas and Lauri Snowden-Label who recognized the important involvement of Judge Daniel Parker and the Parker family to the Colonial period settlement of the area. The project was coordinated with the Barnstable Historical Commission and located on Label-Sollows Dev., Inc. property.

GIVE A BRIEF DESCRIPTION OF HISTORIC IMPORTANCE OF MONUMENT. (Refer to the theme circled on front of form. What happened? Who was important? Comment)

Judge Daniel Parker was the 3rd son of Robert Parker who settled in West Barnstable in 1657. He became a wealthy and large landowner and was very involved in Town affairs and had an outstanding career in law. He was held in high esteem by the inhabitants of the Town. He served in the militia and was chosen a Representative from Barnstable to the Grand Court, was appointed a Justice of the Court of Common Pleas and then Chief Justice. He was also a Proprietor and a Pleader of Law.

In the 1702 division of land he was granted Lot 39 which is near the monument. The area from Oak Street along Race Lane to the West Barnstable-Osterville Road became known as Parker Village by the 1800's with the many Parker family homes and large land holdings.

Daniel Parker won the case for the Indians against the Town for title to Oyster Harbors and was deeded some land there to pay his fee.

Judge Parker's mother married Deacon William Crocker after his father died. His stepfather and stepbrothers had large land holdings, wealth and influence which probably provided a positive measure of support
