The house is a modern vernacular style of one and a half stories. Facing the street is a facade of five bays, which encloses the original carriage shed that measures about 12 x 24 feet. The roof is topped by a louvered square cupola with a weather vane. The front entrance in the center of the façade is enclosed by a small porch. Extending perpendicularly to the rear is a gabled ell containing the dining room. This ell is the original watch shop, about 12 x 13 feet, from which additions have been extended on east and west sides under shed roofs. In 1986 the whole building was moved back from the street about 15 feet and placed on a poured concrete foundation, with a full basement below, and separate entrance on the side. An open porch extends off the south side.

The oldest part of the building may date back into the early 19th century. It was originally located on the William Marston property, and appears there in a photo taken about 1900. It is said to have been used as a blacksmith's shop. It was bought by Dr. James Higgins as a place for his father, David Higgins (1831-1911), to set up his watch shop. David, born in Nova Scotia, learned his trade with Waltham Watch Co. (1850-1852), but went to sea on his father's schooner (1852-1860), then served in the Civil War before following the watchmaking trade. After the war he set up shop in Meridian, Mississippi, then moved up the Mississippi River to Missouri, Chicago, and Redwing, Minnesota. During the boom of watchmaking in Providence, he worked there for a decade (1892-1892), then in Dorchester, Massachusetts, and finally in Marstons Mills, where his father was the country doctor.

In 1913, this 12 x 13 gabled shed was moved half a mile west on River Road to the junction of Lovells Lane by Dr. James Higgins. At the end of that year, Higgins gave the building to Charlotte (Huefner) Gross (1865-1948) (Deed 327-133), whose husband, a bank employee, had been killed in New York by a trolley car, leaving her with two boys. Mrs. Gross was married in 1915 to the neighbor across the street, Gideon Lovell (1857-1953), a licensed practitioner of herbal medicine who worked on an estate in Osterville and did carpentry. Lovell was legendary for walking long distances: he showed up for work at Daniel Brothers Builders in Osterville, complained his feet hurt, then walked home. He would walk to the blacksmith's shop in Cotuit to be sure it was open, then walk home to fetch his horse to be shod.

Historical Narrative, cont'd

Mrs. Gross found a job as housekeeper on the estate where Lovell worked. Lovell is probably responsible for the first enlargement of the house. He is said to have moved a 24 x 12 foot carriage house from the Lovell property across the street, and added the shed-roofed rooms to east and west of the watch shop.

Lovell died in a nursing home in Hyannis in 1953 at the age of 93. Charlotte had died in 1948 and left the property to her son Frank. In 1961 he sold it to W. Clayton Ryder of Glenbrook, CT (Deed1141-125). Four years later, Ryder sold it to Angela (Kearsley, nee Tricone) Steare (Deed1302-442). In 1976, Angela, who died the following year of cancer at age 49, sold it to John M. Newkirk, Jr. of Yarmouth (Deed 2879-77), who in turn sold it to Angela's daughter, Norma R. Martin and her husband George (Deed 2974-238). The Martins sold it to the current owner, Harold M. Roper, in 1979 (Deed 5265-302).

In 1986, Roper had Craig Condinho move the building back from the street 15 feet and place it on a poured concrete foundation. The house was then renovated on plans of architect Tim Heywood, adding four rooms to make a 24 x 42 foot plan (Permit 29795). Roper put on a new roof in 2000 (Permit 49597).
