ARCHITECTURAL DESCRIPTION:

This is a one-story cottage in Colonial Revival style with a suggestion of a Cape Cod cottage. The core 25 x 33 is side-gabled, with central front entrance and brick chimney. This is clad in white vinyl siding, and roofed in composition shingle. At the north end the gable is extended over a short addition. On the east side is a separate 12 x 16 living unit under a gable roof.

The interior has some unusual features. The full basement on a concrete foundation covers only the central portion of the house, about 25 x 28, with crawl spaces on either side, suggesting that there were porches on north and south sides of the core. The center living room has low chair rails, and the center kitchen east of this has bead-board on lower walls.

HISTORICAL NARRATIVE

The house was built in 1920 for the maiden sisters "Fannie" Frances E. Baxter (1855-1942) and "Minnie" Minerva Hinckley Baxter (1862-1946), daughters of Capt. Samuel Sidney Baxter (1828-1907, son of Shubael) and Mary⁸ Marston Hinckley (1834-1911) (Luther⁷, Enoch⁶, Edmund⁵, Benjamin⁴⁻³, Samuel²⁻¹). They were born and grew up in the Alvan Hinckley house built in 1811 across the road at #1745 South County Road (see MM inventory E-4). They inherited hundreds of acres that had been in the Hinckley family since colonial days. This house was immediately north of the ancient Enoch Hinckley homestead (see MM inventory A-18).

After the sisters' deaths it was inherited by Franklin Hinckley Perry (1930-2007), son of their first cousin Anne⁹ Hinckley Perry, then only 17 years old. He married a local woman, Gretchen Reidell, daughter of Carl Reidell of Osterville, and served a career in the US Navy, including the Korean War. The house was sold in 1947 to Frank Edward Wakefield and his wife Maud. After Maud's death in 1966 it was owned briefly by Rhea Davis, wife of E. K. Davis who placed 50 year restrictions before it was sold to Helen P. Hurley, and 1971 to Barbara A. Millin.

In 1984 Hurley sold it to the current owner Cynthia P. Carter (b. 1960) and her engineer husband Stanley R. Tettke (b. 1959). Their son Stephen A. Tettke was born 1986 and grew up here.

Cynthia and Stan were divorced, and she is training to be a nurse. Cynthia was raised in a family whose business was marine salvage.
